Her opponent, Belinda Kaiser was on the Constitutional Revision Commission (CRC) and voted twice to kill the proposed E-Verify Amendment; <u>Vote 1</u>, <u>Vote 2</u>. Keiser felt it was more important to place banning Vaping in Workplaces on the ballot than E-Verify. Keiser ignored expert testimony presented to the CRC on the enormous harm done to legal workers, legal businesses, taxpayers, and victims of illegal alien crime. Keiser's position on illegal immigration is very weak, "*The first act of an immigrant seeking to enter our great country should not be an illegal one by entering without the status to do so. I will end sanctuary cities and believe we need to strengthen our border security to keep our citizens safe."*
